Also, FAST has a Small Games of Chance License, but ideas are needed to utilize it. Crab raffle is being considered for Fast. It was very successful for the senior's Safe and Sane fundraiser.

Discuss led to a yes to free bottles option to sell at games.</p> <p>Joe Macharsky from Kojak sent a promotional item quote for small footballs that can be thrown out during the games. Tina will contact Wellspan to see if they will co-brand them with the Fast logo. Discuss was to order 100.</p>
